# Submittal agreement, Configura Awards 2024

#### Awards submission timeframe

June 20 - August 26, 2024

#### Terms

By submitting an entry, each entrant agrees to the official rules and warrants that their entry complies with all requirements set out in this agreement. This is a skills-based contest and chance plays no part in the determination of winners.

#### Awards categories

#### Who should enter

This competition is open to individuals with a valid CET and/or Spec license at the point of submission (CET Commercial Interiors, CET Kitchen & Bath or CET Material Handling) and a MyConfigura account (or License Manager account for Spec). Employees of Configura and its subsidiaries, their immediate family members or persons living in the same households of such employees (whether or not related) are not eligible.

#### How to enter

Each entry consists of an entry form and a single document which can either be a PDF, rendering, photographic image, 360 panorama or video depending on the category. There is a limit of (1) entry per category per person. Only students currently enrolled in an educational institution can submit their renderings to the student category. Submissions must comply with the following guidelines:

- 1. Content must have been created within three (3) years before the date of entry. Entry cannot previously have won an award in the Configura Awards competition or have been previously submitted to any Configura Awards competitions.
- 2. The content, in its entirety, must be a single work of original material created by the competition entrant. By entering the competition, the entrant represents, acknowledges and warrants that the submitted content is an original work created solely by the entrant.
- 3. Content submitted to the United States. Configura Awards competition must be submitted in English.

- 4. Content submitted cannot contain obscene, provocative, defamatory, sexually explicit or otherwise objectionable or inappropriate content.
- 5. <u>Success Story</u>: Take us on your design journey, demonstrating how you use CET as a tool to reach your success. Must be submitted as a PDF with no more than 4 pages. Do not submit any pricing. Please include at least one rendering or video to showcase your story.
- 6. <u>People's Choice Rendering (CI or MH), Student Rendering</u>: Must be submitted as a highresolution (minimum 1920x1080) in .png or .jpg format that shows your creativity with any size project or products. All renderings must be saved straight from CET and not be manipulated or altered using any other software - include the .cmdrw for verification.
- 7. <u>Rendering Versus Reality</u>: Showcase your ability to take a project from drawing to reality utilizing CET as a tool. Must be submitted with (1) high-resolution rendering (min. 1920x1080) in .png or .jpg format and (1) high-resolution photographic image (min. 200 pixels per inch) to show case your ability to take a project (of any size) from conceptual to reality. Rendering image must be saved directly from CET and cannot be manipulated/altered using any other software- include the .cmdrw for verification photographic images must be original content created by the entrant or individuals from the same organization. Any complications that arise with the public release of such photographs are not subject to Configura's responsibilities.
- Fly Through Video: Take us on a tour of your design project by submitting your favorite flythrough video. Submissions should be no longer than 30 seconds long. Videos can be created directly in CET or Twinmotion. If using Twinmotion, the model must be created in CET and linked to Twinmotion utilizing the "Twinmotion for CET" Extension. Submission must include: (1) .Mp4, (1) CET file- .cmdrw and

(1) Twinmotion local file – if Twinmotion is being used.

- <u>360 Panorama Rendering</u>: Show the full view of any environment by sharing your best 360 panorama. This category can be created directly in CET or Twinmotion. If using Twinmotion, the model must be created in CET and linked to Twinmotion ultilizing "Twinmotion for CET" Extension. Submission should include: (1) MyConfigura/GoogleVR [1024x1024x6 –6M] or Twinmotion panorama file [single panorama-not a set] and (1) CET file-.cmdrw.
- 10. <u>Bid Winning Print Template</u>: Take us on your template creation journey and how that template has won bids and business for your company. Share those creative Look Books, Installation Packages, or striking reports that highlight your brand as a design firm. All templates must have been created by a current or former employee of the company. Submissions must include: (1) PDF of your Print Template story/journey to winning bid with no more than 4 pages, (1) PDF of printed Look Book, Installation Package, or Single Print Report and the (1) .xml Print Template file. Do not submit actual pricing.
- 11. <u>Innovative Extension</u>: For nanufactures only. Show us how your creative use of technology improved the design process. Submission videos should be no longer than 5 minutes in .mp4 format. This category is limited to manufacturers with extensions on the Marketplace.
